Procedures for anchoring attendance initiatives within Multi-Tiered Systems of Support and Student Information Teams will be highlighted.

Restorative Justice with Gabriele Ross, Restorative Justice Trainer/Coach, Resolutions Northwest Unacceptably high push-out rates that disproportionately affect students of color, and changes in state law mandate us to rethink how we do discipline in schools. Restorative Justice is a valuable alternative to exclusionary practices that often lead students to not attending school anymore at all.
